Vision Care...Easy as 1, 2, 3!

Vision Service Plan, your new vision care provider's method for delivering benefits allows you to receive quick and direct access to vision care without completing any paperwork. The member doctor will contact VSP on your behalf to obtain authorization for services. Follow the convenient steps below and you'll be on the way to quick and easy vision care benefits.

- 1. Consult your VSP brochure (available from your benefits office) for a description of your plan coverage.**

- 2. The next step is to call a VSP member doctor (listed below) for an appointment and identify yourself as a VSP member.** You aren't required to complete any up-front paperwork. That's it! If you need assistance in locating a member doctor, please contact your benefit's office or call (800) 877-7195.

When you call, tell the VSP member doctor the covered member's social security number and that your benefits are through Plumbers & Steamfitters #248 (12-049038).

(If you choose to visit a non-member doctor, VSP still provides coverage. See your plan brochure for details.)

- 3. After you've scheduled your appointment, the VSP member doctor will contact VSP to verify your eligibility and plan coverage.** The doctor will also obtain authorization for services and materials. If you're not eligible for benefits at that time, the doctor will communicate that information to you.
